

## Winsulation Contest Official Rules

### ELIGIBILITY:

- To be eligible to enter and win a Prize, you must be a resident of Newfoundland and Labrador. You are not eligible to enter or win a Prize if you are an employee of Newfoundland Power or Newfoundland and Labrador Hydro (the Sponsors), their affiliates and related companies, advertising or promotional agencies or a member of the immediate family of such employee (defined as parents, siblings, children and spouse, regardless of where they live). To be declared a winner of the Prize, your home and project must meet all existing eligibility criteria for the takeCHARGE Insulation Rebate Program including:
  - a) You must be the homeowner and your home must have an active electricity account.
  - b) Your home must be on a permanent foundation and intended as a residence.
- Only insulation required to complete the insulation project is eligible for the rebate. The insulation must meet R-Value requirements:
  - a) Minimum R18 to maximum R25 for basement and crawl space walls.
  - b) Minimum R30 to maximum R35 for basement and crawl space ceiling.
  - c) Minimum R50 to maximum R55 for attics.
- The rebate applies to pre-tax insulation costs. Other materials and labour will not be reimbursed. Insulation must be purchased after the date the Prize is awarded. You may add to existing insulation to reach the recommended R-value, but the rebate will not be provided to replace existing insulation.
- The Prize will be paid for basement/crawl space walls or basement/crawl space ceiling insulation upgrades, but not both, and for attic insulation upgrades.
- No purchase necessary. If the winner is not eligible for the insulation rebate, or has already completed an insulation upgrade, they are permitted to transfer the Prize to a friend or family member that meets the eligibility criteria or they may choose a \$600 credit towards another eligible energy efficient product or products included in the suite of takeCHARGE residential programs. This value represents the difference between the average takeCHARGE insulation rebate and the average total pretax material costs to insulate the attic and basement, to a maximum \$1,500 per area, for customers who have received a rebate.
- Rebate must be claimed by March 31st 2017.
- Winner does not need to be present when Prize is drawn to win.
- There will be one Prize drawn on Friday March 18, and one Prize on Sunday March 20.
- Newfoundland Power and Newfoundland and Labrador Hydro may visit your home and inspect the insulation upgrade at any time within 15 months from the date of application.

**HOW TO ENTER:** Fill out and submit a ballot at the takeCHARGE booth at Home Show to be entered in the draw. Only one ballot per household is allowed.

**PRIZES:** The Prize is an on-bill credit of the amount necessary to increase the rebate to which the prize winner is entitled under the terms of the takeCHARGE Insulation Rebate Program as stated above such that the prize winner receives a total amount, including the takeCHARGE rebate, equal to 100% of the pretax cost of insulation materials required to insulate a home to R-Value levels outlined in the Insulation Rebate Program (a "100% Rebate") or, where the prize winner is not a participant in the takeCHARGE Insulation Rebate Program, a \$600 credit towards another eligible energy efficient product or products included in the suite of takeCHARGE residential programs. Maximum rebate is \$1,500 for attic insulation and \$1,500 for basement insulation. The odds of winning a prize in the Contest will depend upon the number of eligible Entries received during the Contest Period. Prizes are awarded by random draw from entries received. Only one winner per household is allowed.

**PRIZE CLAIM(S):** To receive the Prize, the selected entrant must apply by mail or online at [TakeChargeNL.ca](http://TakeChargeNL.ca) for the insulation rebate and submit a copy of the winning ticket at the time of application. To choose the gift card option, the selected entrant must advise takeCHARGE staff at the time of notification of winning. To be declared a winner of a Prize, you will be required to state your name, mailing address and date of birth and to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question, to be administered by phone. If an entrant fails to correctly answer, or, incorrectly answers the skill-testing question; the Prize will be forfeited and may be awarded to an alternate entrant.

Newfoundland Power and Newfoundland and Labrador Hydro will not honour warranties and guarantees, and are not responsible for any damage caused by the installation of these products.

**RIGHT TO TERMINATE, SUSPEND OR AMEND:** Sponsor reserves the right to terminate, amend or suspend this Contest, in whole or in part, without prior notice.

**MISCELLANEOUS:** Claimants who have not complied with these Official Contest Rules are subject to disqualification from this Contest. All decisions of the Sponsor are final and binding without right of appeal in all matters relating to this Contest. The Releasees will not be responsible for illegible, incomplete, lost, misdirected or late Prize claims, all of which will be void. Contest is subject to all applicable federal, provincial and municipal laws.
