**\*TERMS AND CONDITIONS:** To be eligible for this rebate, all required information must be completed, including a valid electricity account number, and a copy of purchase receipts. An annual oil statement or receipt showing a minimum of 1,000 liters of consumption is required for oil heated homes. Your home and project must meet all eligibility requirements. Offer subject to change or cancellation without notice. Please allow up to 8 weeks for the on-bill credit. Newfoundland Power and Newfoundland and Labrador Hydro will not honour warranties and guarantees, and are not responsible for any damage caused by the installation of these products. Newfoundland Power and Newfoundland and Labrador Hydro may visit your home and confirm the insulation installation at any time within 15 months from when the rebate was processed.

## ELIGIBILITY REQUIREMENTS\*

<ul style="list-style-type: none"> <li>Your primary source of heat is an electric furnace or ducted central heat pump. If an additional heating source is used, your home must have a minimum annual electricity usage of 15,000 kilowatt hours (kWh).</li> <li>You are the homeowner and the home has an active electricity account.</li> <li>Your home is on a permanent foundation and is intended as a primary residence.</li> <li>Contractors and owners of rental properties can participate in the rebate programs if they meet eligibility requirements.</li> <li>New and existing homes can qualify for the duct insulation rebate.</li> <li>If you have received a rebate for duct insulation from another program, your takeCHARGE rebate may be prorated to ensure you do not receive a total rebate greater than 100% of your pre-tax material purchase.</li> </ul>	<ul style="list-style-type: none"> <li>Your home uses at least 1,000 litres of oil annually. A copy of a current annual statement that shows a minimum of 1,000 litres of oil consumption must be included with application.</li> <li>You are the homeowner and the home has an active electricity account.</li> <li>Your home is on a permanent foundation and is intended as a primary residence.</li> <li>Contractors and owners of rental properties can participate in the rebate programs if they meet eligibility requirements.</li> <li>New and existing homes can qualify for the duct insulation rebate.</li> <li>If you received funding for duct insulation through the Home Energy Savings Program you are not eligible for this rebate.</li> </ul>

## DUCT INSULATION REQUIREMENTS

- Rebate only applies to ductwork in **unheated** spaces.
- Insulation added to ductwork must have a minimum R-Value of R-6 and a maximum of R-8.
- Rebates are only available for the amount of duct insulation required to complete your project.
- The rebate applies to pre-tax insulation costs. Other materials and labour will not be reimbursed.
- Insulation intended for the purpose of insulating ductwork such as duct wrap or duct sleeves must be used for this project. It is not recommended to attempt to insulate your ductwork with other types of insulation.
- Duct insulation was purchased on or after September 26, 2022.

A copy of your purchase receipts must be included with the completed application. If your home is heated by oil, you must also include a current statement or receipt that shows a minimum of 1,000 litres of annual oil consumption.
