## 2024 - 2025 K-I-C Contest Grades K-6

## OFFICIAL CONTEST RULES

## 1. ELIGIBILITY:

- a. To be eligible to enter and win the Prize, you must be a K-6 class in the Newfoundland and Labrador school system.
- b. Each class may enter only once.
- c. The school name and location, along with the teacher's name, grade level and the number of students in the class must be included.
- d. Video submissions should be no longer than 5 minutes in length.
- 2. ## 3. CRITERIA FOR JUDGING:

- a. Appearance and creativity
- b. Accuracy of the message
- c. Effectiveness (interest and appeal to the audience)
- 4. PRIZES: There will be two Grand Prizes of Chapters gift cards valued at \$2500 and three Second Prizes of Chapters gift cards valued at \$1500 for each of the Sponsors' service territories. (The "Sponsors" are Newfoundland Power Inc. and Newfoundland & Labrador Hydro.)
